## Use of Facility Procedure and Rules

\_\_\_\_\_ In executing this agreement, Applicant certifies that he/she has been duly authorized by the organization to act on its behalf in making application for said facilities.

\_\_\_\_\_ The Applicant affirms that the facility will be used only as stated on page 1.

\_\_\_\_\_ Applicant understands that the grounds shall not be used for any of the following activities:

1. Any use by an individual or group for the commission of any crime or any act prohibited by law.
2. Any use which involves the possession, consumption, or sale of alcoholic beverages or any restricted substances, including tobacco use.
3. The Applicant understands (LP) gas or Propane/Butane grills are not permitted.
4. Pets are not allowed in the facility

\_\_\_\_\_ Applicant understands that the TSP shall have priority use of the facilities. It is recognized that there may be situations when the request for facilities will need to be rescinded due to an unforeseen event. TSP will make every effort to communicate this change in a reasonable timely manner and find you appropriate accommodation in case of last minute changes.

\_\_\_\_\_ Applicant understands that the County Fairgrounds has special events that will close down the facility for ALL uses (Annual Fair, LAC Concert, Swap meet). TSP will ensure this is reflected on your agreement.

\_\_\_\_\_ **HOLD HARMLESS & INDEMNIFICATION AGREEMENT:** I certify that I represent the above organization, and that the sponsoring organization, individual members of the sponsoring organization, and any and all participants and attendees for themselves, their spouse, heirs, administrators, executors and assignees, releases and shall hold harmless the board members, Turlock Sports Park officers and employees from any claim or demand, including those based on the negligence of the board members, Turlock Sports Park officers and employees, arising from participation or attendance at this activity or function held at the facility.

\_\_\_\_\_ Organizations will provide proof of insurance for personal liability and property damage in the amount of at least \$1 million for each occurrence and \$2 million aggregate. The Applicant will list Turlock Sports Park, officers, agents, employees, volunteers as an additional insured, and name them as the certificate holder. (Due at least seven days prior to event.)

\_\_\_\_\_ The Applicant understands that the area is to be cleaned and left in good condition, or \$30 an hour fee may be charged.

\_\_\_\_\_ The Applicant understands that groups, organization, or persons using the facility shall be liable for any property damages caused by the activity. **The Applicant understands that vehicles are not permitted on fields.** The organization may be charged the amount necessary to repair the damages and may deny the group further use of the facility.

\_\_\_\_\_ The total fee is due to Turlock Sports Park for recurring rentals at least seven days prior to use for each month.

\_\_\_\_\_ Notification of any changes/cancellation to dates/times of use that may result in a recalculation of fees must be reported in writing to the Director within 48 hours of each occurrence, otherwise all fees will be due.

\_\_\_\_\_ Turlock Sports Park reserved the right to control the operation of a concession at any and all events. No food items will be offered for sale at the facility without prior written approval from Turlock Sports Park, and a Health Department approval.

\_\_\_\_\_ To sell any items, T shirts, hats, etc. Turlock Sports Park will assess a \$100 vendor fee for each booth.
